**PAYMENT** – Membership fees must be paid in full to receive privileges.

PARTICIPATING COURSES – Participating courses in the 2016 Philaware Signature Club Membership are; Cobbs Creek, FDR, John F. Byrne, Lederach, Rock Manor, Ed Oliver and Delcastle. This list of courses is subject to change at any time

**REFUSAL OF PRIVILEGE** – Any participating course has the right to refuse golf course or other privileges to anyone who is deemed to be in violation of this agreement and/or the course's rules.

**TEE TIMES** – Tee times may be obtained up to 10 days in advance via the Internet, over the phone or in person at the Golf Shop. Those reserving tee times are responsible for checking-in with the number of players booked. Please extend the courtesy of calling in advance to cancel your tee time or to report a lower number of players. Members who short show or no show regularly are subject to no show charges and/or the loss of advance booking privileges.

MEMBER PRIVILEGES – The Member's home course privileges include golf and cart (if cart is included in the membership option selected) during membership privilege hours. Additional privileges include 10 day advance tee times, 10% off guest fees (for up to 3 guests), 10% off merchandise (excluding sale and special order), discounted rate for special events and 50% off range balls (if available at the home course). The Member's visiting course privileges include golf benefits and/or discounted rates as outlined in membership collateral and on the golfphilly.org website. All privileges are subject to change, and expire 12.31.16.
